Members receive regular communications, may volunteer with our community development and advocacy projects, may attend the Annual General Meeting, may vote for the Board of Directors, and may also sit on the Board of Directors. Becoming a member of Community Legal Services of Ottawa is FREE. Membership is effective for 3 years, and must be renewed to stay active. The legal clinic will contact you when your membership needs to be renewed. **Please note that members must be at least eighteen (18) years of age and must either live or work in the City of Ottawa.**
